RCT Operates Multiple Transportation Systems:

- **Shuttle/Commuter/Shopper Bus System:** Fare-free bus service throughout locations in Caledonia, Orleans and Lamoille Counties, connecting riders to destinations throughout Vermont and beyond.
- **Dial-A-Ride System:** Fare-free demand response which provides seven-day-a-week transportation for medical appointments, shopping, job access, socialization and more. See page 9 for more information.
- **Microtransit Program:** This free on demand service connects Hyde Park, Morrisville, and Elmore. Trips can be scheduled using the RCT Microtransit App, by phone, or computer. See page 9 for more information.

More about RCT:

Rural Community Transportation, Inc. (RCT), is a private nonprofit 501(c)(3) corporation which provides public transportation services throughout Caledonia, Orleans, Essex and Lamoille Counties. RCT operates fare-free shuttle and commuter bus routes which allow connections between towns in our region as well as the ability to travel throughout Vermont and beyond. In addition, RCT provides demand response transportation services under several programs, such as Medicaid, the Older Adults and People with Disabilities program and Rides 2 Wellness.

Emergency Text Alerts.

Severe weather or other hazardous conditions may occasionally impact services. You can sign up at RideRCT.org to receive alerts regarding route specific delays or cancellations on your cell phone.



Guaranteed Ride Home.

Register your commute at connectingcommuters.org. Then if an emergency arises that keeps you from taking your bus home. Go! Vermont will reimburse up to \$70 worth of travel costs, six times per year.

RIDER GUIDE Continued...

CHILD SEATS

All new RCT buses have built-in child seats and seat belts at every seat. Ask your bus driver for assistance if you need help. If you bring your own child seat, please be sure it is secured correctly.

TRAVELING WITH YOUR BIKE? NO PROBLEM!

Riders are responsible for loading/unloading their own bikes, securing them for safety and removing items that are loose or block driver's visibility. Bikes may also be brought in the bus if the bike rack is full and the driver says it is safe to do so.

TRAVELING WITH A SERVICE ANIMAL? GREAT!

Service animals are allowed on RCT buses. All animals must be under control at all times to ride. Non-service animals are not permitted.

OVERSIZED ITEMS

Skateboards, skis and snowboards are welcome on the bus provided they are kept out of the aisles.

LOST AND FOUND

RCT is not responsible for items left on the bus. Perishable and soiled items will be disposed of for safety reasons. All other items will be kept in lost and found for 30 days. Call dispatch to see if your item has been found and how you may claim it.



CODE OF CONDUCT

IN CONSIDERATION OF OTHERS:

- Please move to the rear of the vehicle so others may board quickly
- Please keep aisles clear and take your belongings with you
- Please wear appropriate attire; shirt and shoes are required
- Food and beverage must be in closed containers
- Use of any type of tobacco, e-cigarettes, alcohol or other drugs as are prohibited in vehicles
- You may not board an RCT vehicle if you are under the influence of any type of drug or alcohol
- Pets are not allowed, service animals are always welcome
- Threats to other passengers and/or drivers will not be tolerated
- No unruly behavior or weapons of any kind are permitted
- Allow the operator to drive safely by not speaking with him/her while the vehicle is moving
- Wear headphones when playing audio or video devices and please keep at a low volume



SAFETY & ACCESSIBILITY

SAFETY PLEDGE

RCT pledges to ensure the safety of its passengers, drivers, rider coordinators, employees, volunteers and community members through the following commitments:

- Background checks completed for staff and drivers;
- Random drug and alcohol testing program for all staff;
- Buses are inspected prior to every shift and receive regular preventive maintenance;
- Volunteer vehicles are inspected for safety and cleanliness.
- RCT pledges to constantly renew its efforts towards safety and to continuously seek new programs and opportunities to increase system safety.

EMERGENCY INFORMATION

Occasionally, RCT needs to cancel a route or close early due to severe weather or other hazardous driving conditions.

WHEELCHAIR LIFTS AND SPECIAL ASSISTANCE



Wheelchair lifts are on every bus and drivers are trained to assist riders who need them in getting on and off the bus. To ensure the best possible service, riders needing special assistance are encouraged to call 802-748-8170 ahead of time. Please note, the step height to board our buses is between 10" and 12".

TITLE VI OF THE CIVIL RIGHTS ACT

RCT operates its programs and services without regard to race, color, and national origin as stipulated in Title VI of the Civil Rights Act of 1964. If you feel you have been discriminated against based on your race, color, or national origin, you may file a written complaint with the Executive Director, Rural Community Transportation, Inc, 1677 Industrial Parkway, Lyndonville, VT 05851. A written complaint may also be filed with the Title VI Program Coordinator, FTA Office of Civil Rights, East Building, 5th Floor – TCR, 1200 New Jersey Ave., S.E., Washington, DC 02590, or a complaint may be made to the Vermont Agency of Transportation, Office of Civil Rights by calling 802-595-6959 or by using the complaint form on their website at vtrans.vermont.gov/civil-rights/compliance/titlevi/complaint. VERMONT STATE PUBLIC ACCOMMODATION LAW

9V.S.A. 4502 (a) Public accommodations states an owner or operator of a place of public accommodation or an agent or employee of such owner or operator shall not, because of the race, creed, color, national origin, marital status, sex, sexual orientation, or gender identity of any person, refuse, withhold from, or deny to that person any of the accommodations, advantages, facilities, and privileges of the place of public accommodation. If you feel you have been discriminated against, you may file a complaint with Vermont Human Rights Commission by calling 800-416-2010 or by email at human.rights@vermont.gov.

ADA REASONABLE MODIFICATION POLICY

In accordance with FTA 49 CFR, Parts 27 and 37, RCT, is committed to ensuring a reliable, accessible experience for all customers. All requests for reasonable modifications to RCT programs and services will be considered on an individual basis. Please note that RCT may be unable to accommodate requests for reasonable modifications which would result in a fundamental alteration to the nature of RCT programs and services, or which would directly interfere with the health and safety of others. In the event that a barrier to access exists, but the requested modification cannot be granted, RCT will, to the maximum extent possible, assist in determining an alternate reasonable modification to provide equivalent access to its programs and services.

DIAL-A-RIDE

DIAL-A-RIDE PROGRAMS

These services are for people for whom regular bus service does not work. This System enhances RCT's ability to provide comprehensive transportation alternatives for all Caledonia, Essex, Orleans and Lamoille County residents.

The Dial-A-Ride System includes programs that focus on specialized populations including elders, persons with disabilities, low-income families and individuals, as well as the visually impaired. If you are eligible for Medicaid, are aged 60+, or have a disability, you may be eligible for FREE transportation. This program is supported by Volunteer Drivers who are reimbursed for mileage.

OLDER ADULTS AND PEOPLE WITH DISABILITIES

Free for all Caledonia, Essex, Orleans and Lamoille County residents who are age 60 or older and/or have a disability, as described in the Federal 1991 ADA. Our partner funding agencies are: Age Well, Counseling Service RCT. Services can include rides to: food shopping, medical, social and other necessary appointments.

NON-EMERGENCY MEDICAL TRANSPORTATION

RCT provides free transportation through various programs. Please call (802) 748-8170 to see if you qualify.

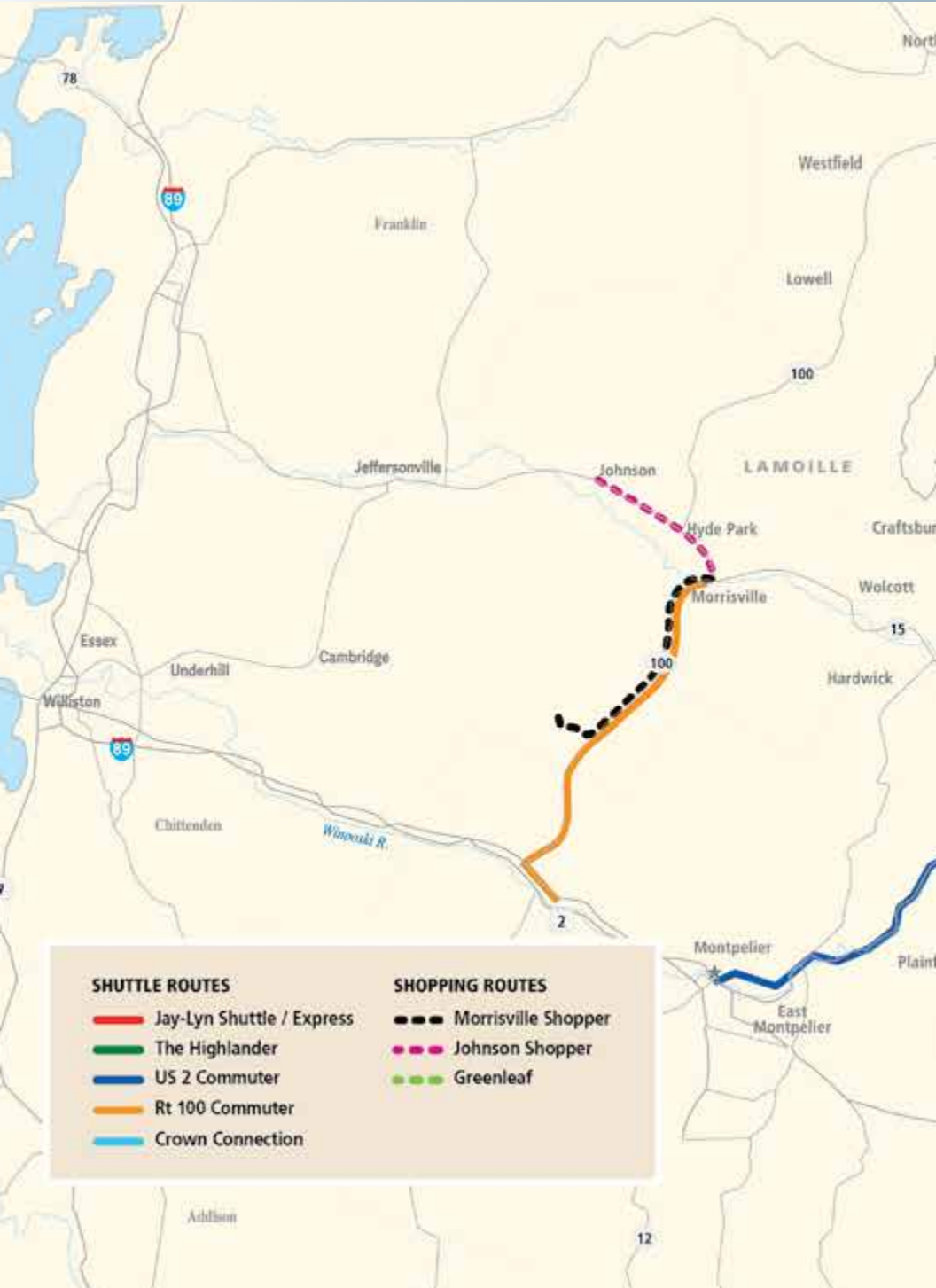
MICROTRANSIT - HyMor

The HyMor is RCT's new Microtransit program. This free service connects Hyde Park, Morrisville, and Elmore Monday through Friday (*except major holidays*), from 8 am to 5 pm. Trips can be scheduled in advance or on the day of request using the new RCT Microtransit App, by phone, or on your computer.

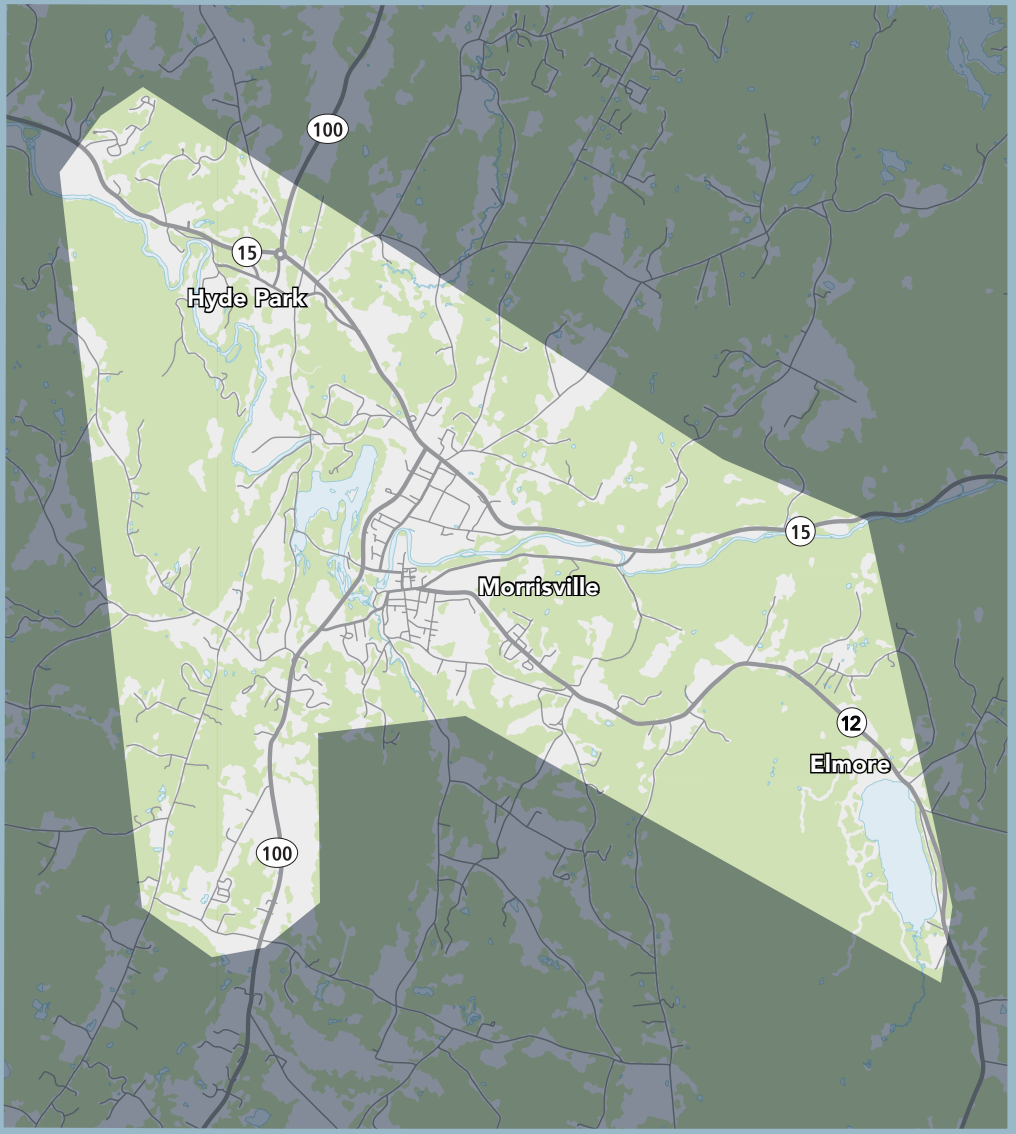
HYMOR:
