

It is the vision of RCT to establish a solid foundation for regional

development of a safe efficient public transportation system.

RCT Mission Statement

It is the mission of RCT to:

- 1. Encourage the use, development and support of safe public transportation
- 2. Provide coordinated, consolidated, non-duplicative transportation services
- 3. To promote the planning and development of public transportation.

Company Profile

Rural Community Transportation, Inc. (RCT) is a private, non-profit organization incorporated in November 1991.

RCT is a transportation brokerage, that uses all modes of transportation including buses, cars, taxis, and volunteer drivers. We service a wide range of passengers through several programs as well as providing rides to the general public. As the Medicaid broker for Caledonia, Essex, Lamoille and Orleans counties, RCT coordinates medical trips for Medicaid eligible residents with trips for other local agencies.

RCT provides transportation services for the Northeast Kingdom Council on Aging, Adult Day Health Services, Northeast Kingdom Human Services, Central VT Council on Aging, Lamoille Day Health Services, and Northeast Kingdom Community Action Agencies under the Elderly and Disabled programs, funded through VT Agency of Transportation. Through all of our programs, in FY 18 RCT logged over 244,109 rides.

The moving force of RCT is its volunteer driver network. The demand for service continues to increase the volunteer driver network, bringing people in from the outlying areas to the more heavily populated service centers. The service area of RCT includes Caledonia, Essex, Lamoille, and Orleans counties of Vermont. The main office is in Lyndonville with branch offices in Newport and Morrisville.

Partnerships

RCT works closely with our partner agencies including The Northeast Kingdom Council on Aging (NEKCOA), The Central Vermont Council on Aging (CVCOA), Riverside Life Enrichment Center (RLEC), Lamoille Adult Health Services, the Northeast Kingdom Human Services (NEKHS) and the Northeast Kingdom Community Action Agencies (NEKCA), local Federally Qualified Health Care centers, local hospitals, and with 2 local Planning Commissions, NVDA and Lamoille Planning Commission. RCT is an active member of the Public Transit Advisor Council (PTAC); the Vermont Public Transit Association (VPTA), 4 local Chambers of Commerce, AARP, and the Northeast Kingdom Collaborative. Administrative Staff from RCT attend monthly meeting with each of these as well as attending monthly Blueprint for Health meetings in Newport, St Johnsbury and Morrisville.

In support of the partners and local towns RCT has:

- * Provided free shuttle service to St Johnsbury for First Night
- * Participated in Stars and Stripes festival in Lyndonville
- * * Provided free transportation for the Christmas Light program in St. Johnsbury with the ST Johnsbury Police Department
- Provided shuttle transportation in Newport to celebrate the 100th anniversary

In FY 17 RCT was awarded a \$51,179 grant which RCT was very excited to work on during FY 18. This is the "Uber" of the Northeast Kingdom. This project is putting trackers in the shuttle buses, our wheelchair accessible vans and a limited number of volunteer driver so the public can see where the vehicles are and call into a dedicated number to see if there is room on the vehicle and what the cost is to ride. Town Taxi in St. Johnsbury has also partnered with RCT. Another part of this project is a real time app that will track the shuttles and let the public know where the bus is and when it will be at your pick up. This is through the Swiftly App and the Transit App. By the end of FY 18 Swiftly app pulled out as it was a localized app and the Tranist App is international.

Volunteer Drivers

Volunteer drivers are the foundation of Rural Community Transportation. They have been a driving force from the beginning. Each and every day these dedicated people reach out a helping hand to those in need by providing safe reliable transportation to medical appointments, meal sites, adult day health services, educational facilities, and grocery shopping. RCT continuously strives to expanded its volunteer driver program.

In this fiscal year volunteer drivers provided 129,550 rides, travelling across 3,713,420 miles. Collectively, the volunteer drivers have donated 92,190 hours of their precious time to provide these trips.
